1: MPhil in African Studies

There is no funding available from the Department for MPhils undertaking fieldwork. Students wishing to undertake research abroad will incur costs for flights, accommodation and subsistence. If you have any concerns about this please speak the admissions administrator before applying, noting that research abroad is not a mandatory part of the MPhil course.

2: PhD in Antarctic Studies

Certain projects may require additional funds for fieldwork or laboratory costs. In some cases students may need to contribute to these costs.

3: MAST in Applied Mathematics

All MAST courses are treated as undergraduate courses for fee purposes. Overseas students are therefore also charged the undergraduate College fee. This varies from College to College. The *estimated* financial liability for the overseas College fee for admission in 2017–18 ranges between £6,580 and £12,264 and is in addition to the University Composition Fee and maintenance costs.

4: MPhil in Archaeological Research

Additional costs may be incurred in relation to fieldwork or research trips. Applicants should discuss any additional costs with their potential supervisor prior to application.

5: MPhil in Archaeology

Fieldtrips specified as part of the course do not incur additional costs to students.

A non-compulsory fieldtrip to Wessex, available to all MPhil students in the Department, is charged at a heavily subsidized rate, typically £50.00.

Costs may be incurred by students in the course of data collection or fieldwork for their dissertation depending on their topic. Such topics or methods are not prescribed and alternative projects incurring no additional costs will be available to all students.

6: PhD in Archaeology

Additional costs may be incurred in relation to fieldwork or research trips. It is possible to apply for additional funding to cover some of these costs. Additional costs may also be incurred in the case of laboratory based research. Applicants should discuss any additional costs with their potential supervisor prior to application.

7: PhD in Architecture

Most of our students find it useful to work with a laptop.

Whilst our libraries are excellent, some students prefer to purchase books for their own use. They may also choose to undertake research which necessitates specialist equipment and materials.

The Department advocates that students plan for research which they can arrange funding for. Fieldwork, visits and research which take(s) place overseas can be costly.

8: MPhil in Architecture and Urban Design

Any full-time student eligible for the Home rate of fee who has completed Part 1 will be treated as a continuing student for the duration of the course even if they switch institutions between Part 1 and Part 2 as long as they do not change their mode of study (eg from full- to part-time), and do not have a gap of more than three academic years after completing Part 1. Contact grad.enquiries@aha.cam.ac.uk if you think that you may be eligible to be charged a fee different from that shown above.

While there are bursaries available on a competitive basis, students are expected to meet or arrange for the costs of their fieldwork. Students are also expected to fund their own materials and equipment (eg paper and print).

9: MPhil in Architecture and Urban Studies

The department subsidises printing for all students, although students have to cover part of the cost. Other costs include voluntary trips to conferences, usually within the United Kingdom. Sometimes, field trips are useful in order to carry out research. The University and many of its Colleges offer small bursaries for graduate students to give papers at conferences and go on field trips. Bursaries are awarded on a competitive basis and may not cover the full cost of the trip. Students are expected to purchase relevant books and other basic working material (such as stationery).

10: MPhil in Assyriology

Fieldtrips specified as part of the course do not incur additional costs to students.

A non-compulsory fieldtrip to Wessex, available to all MPhil students in the Department, is charged at a heavily subsidized rate, typically £50.00.

Costs may be incurred by students in the course of data collection or fieldwork for their dissertation depending on their topic. Such topics or methods are not prescribed and alternative projects incurring no additional costs will be available to all students.

11: MAST in Astrophysics

All MAST courses are treated as undergraduate courses for fee purposes. Overseas students are therefore also charged the undergraduate College fee. This varies from College to College and is in addition to the University Composition Fee and maintenance costs. Visit the [International Students Fees page](#) on the Undergraduate Study website for more details.

12: MPhil in Biological Anthropological Science

Additional costs may be incurred in relation to fieldwork or laboratory work, depending on the applicant's specific research interests. Applicants should discuss any additional costs with their potential supervisor prior to application.

13: PhD in Biological Anthropology

Additional costs may be incurred in relation to fieldwork or laboratory work, depending on a student's research interests. Applicants should discuss any additional costs with their potential supervisor prior to application.

14: MPhil in Biological Science (Zoology)

Additional research costs are likely (e.g. lab consumables or fieldwork), but the amount will depend on the nature of the project. Applicants should discuss requirements with the prospective supervisor, who will be asked to confirm how these costs will be met prior to a conditional offer being made.

15: PhD in Biological Sciences at the Department of Veterinary Medicine

Depending on the project chosen by the student there may be additional expenses incurred for consumables or use of specialised equipment or services. A project may also incur additional costs if there is a large amount of travel and fieldwork required. We will endeavour to keep the amount to be charged to the student to a minimum and this will be discussed with the candidate prior to any offer being made. Most projects offered by the Department are without additional costs.

16: MPhil in Bioscience Enterprise

Additional Costs: £ 500

This is to cover additional expenses incurred by students whilst participating in activities associated with the programme. Activities may include UK company visits; conference attendance; travel, occasional meals and refreshments; joint membership of an industry organisation and other miscellaneous expenses. Payment is requested at the start of the Michaelmas term.

There is also usually an opportunity to gain a global perspective of the industry sector during a study tour to an international biotechnology business cluster, an event that is planned and led by members of the class. The study tour is personally financed by the students. Occasionally a small contribution to the cost of travel is provided by Colleges, but this support is not universal or guaranteed.

18: CRUK Cambridge Centre MRes + PhD in Cancer Biology

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

19: MRes + PhD in Cardiovascular Research

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

20: EPSRC CDT MPhil + PhD in Computational Methods for Materials Science

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

Certain projects may require additional funds for laboratory, fieldwork and long-term attachment costs. This could include equipment, books, IT, photocopying, bespoke training, travel for conferences, research trips, summer schools and fieldwork costs.

Supervisors are often able to cover or partially contribute to these costs, depending on the financial resources available. Where not possible, or where research-related costs are not specifically included in a stipend, or if students are self-funded, students will usually be expected to raise the associated research costs themselves. In some cases research costs may be much higher, for example if a long-term attachment is required, and in these cases applicants should agree with their supervisor what an appropriate amount might be, or consider a more feasible project, before accepting an offer or signing the Financial Undertaking Form.

21: MPhil in Conservation Leadership

In some cases students undertake fieldwork for their professional placement which incurs additional costs.

These costs are sometimes covered by the organisation hosting the placement, and in addition up to £500 is available from course funds for travel and appropriate expenses. However, in some cases there is a shortfall that needs to be covered by the student from their personal funds. Any such potential shortfall is made clear at the stage of selecting a placement. There are always many placements available that involve no additional cost to students, meaning that the availability of additional funds is not in any way a limiting factor on the ability of a student to complete the course. Where additional funds need to be raised for a placement, students are sometimes able to find support from their college or departmental fieldwork funds, although these cannot be guaranteed. The maximum shortfall that a student might need to find to cover a placement that involves additional costs is in the region of £1500, although this would be a very rare case.

22: MPhil in Development Studies

There is no funding available from the Department for MPhils undertaking fieldwork. Students wishing to undertake research abroad will incur costs for flights, accommodation and subsistence. If you have any concerns about this please speak to the admissions administrator before applying, noting that research abroad is not a mandatory part of the MPhil course.

23: PhD in Development Studies

There might be additional costs linked to fieldwork. There is only limited financial help available through the Department to support the costs of fieldwork and applicants should not expect to rely on this as the sole source of funds for their fieldwork.

24: MPhil + PhD in Developmental Biology

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

25: Doctor of Business

Students should take note that additional costs for travel and accommodation may be incurred during the residential periods in Cambridge. Some Colleges may be able to offer accommodation, but this should be discussed on an individual basis.

The fees for year 1 of the course are £80,000. The fees for years 2, 3 and 4 are £50,000 per year.

26: MPhil in Earth Sciences

The MPhil in Earth Sciences often involves significant field work and lab work. It is impossible to provide general statements on these costs as they depend on the specific area of work. Applicants considering self-funding must discuss the potential costs with the supervisor before accepting an offer.

27: PhD in Earth Sciences

PhDs in Earth Sciences often involve significant field work and lab work. It is impossible to provide general statements on these costs as they depend on the specific area of work. Applicants considering self-funding must discuss the potential costs with the supervisor before accepting an offer. Where a funded PhD place has been offered by the Department these costs will be included in the studentship awarded.

28: PhD in Education

If students are conducting fieldwork there will normally be expenses associated with this. These will vary, depending on the nature and location of the fieldwork. Students can apply for financial assistance to help with the costs of fieldwork but there is no automatic entitlement to a particular level of funding. Awards are likely to be for no more than around £2500 and only expenses over and above those which would normally be incurred in Cambridge would be considered..

29: Doctor of Education

If students are conducting fieldwork there may be expenses associated with this. These will vary, depending on the nature and location of the fieldwork.

The fees for this course are subject to an inflationary increase each year and you should take this into account when planning your finances.

30: MPhil in Education (Psychology and Education)

Additional Costs: £ 1,479

This course is accredited as a graduate conversion course by the British Psychological Society (BPS) provided students complete work in addition to the master's during their time with us.

Graduate basis for chartered membership (GBC), granted by the BPS, allows you to proceed onto courses offering professional training as a chartered psychologist (for example, educational or clinical psychology). If you are not planning to become a chartered psychologist in the UK, then GBC is not a necessary element for your master's work with us, so you can simply follow the Psychology and Education Master's without the additional BPS element. In such cases the additional fee will not be payable.

31: Master of Education (Psychology and Education)

Additional Costs: £ 1,479

This course is accredited as a graduate conversion course by the British Psychological Society (BPS) provided students complete work in addition to the master's during their time with us. This optional extra element carries a fee for the course.

Graduate basis for chartered membership (GBC), granted by the BPS, allows you to proceed onto courses offering professional training as a chartered psychologist (for example, educational or clinical psychology). If you are not planning to become a chartered psychologist in the UK, then GBC is not a necessary element for your master's work with us, so you can simply follow the Psychology and Education Master's without the additional BPS element. In such cases the additional fee will not be payable.

32: MPhil in Egyptology

Fieldtrips specified as part of the course do not incur additional costs to students.

A non-compulsory fieldtrip to Wessex, available to all MPhil students in the Department, is charged at a heavily subsidized rate, typically £50.00.

Costs may be incurred by students in the course of data collection or fieldwork for their dissertation depending on their topic. Such topics or methods are not prescribed and alternative projects incurring no additional costs will be available to all students.

33: EPSRC CDT MRes + PhD in Future Infrastructure and Built Environment

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

34: EPSRC CDT MRes + PhD in Gas Turbine Aerodynamics

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

35: MPhil in Geographical Research

Although not mandatory, some students conduct fieldwork as part of their pilot study. This often takes place in Cambridge to test methodological approaches. Alternatively, some students travel to research sites away from Cambridge. These trips may incur additional travel and maintenance costs for the student.

36: MPhil in Geography

Certain projects may require additional funds for laboratory costs or field-work costs (see the [Graduate Price List page](#) on the Department of Geography website for details).

Applicants should select the MPhil in Geography when making their application. Overseas (non-EU) applicants will need to be aware that different conditions apply depending on the topic of the research project. The department will decide which category your application falls into. This will be either Natural Science/Physical Geography, which carries the Science fee and requires an ATAS statement, or Social Science and Humanities/Human Geography, which carries the Arts fee and does not need an ATAS statement.

37: PhD in Geography

Additional costs may be incurred in relation to fieldwork, research trips or laboratory work. Applicants should discuss any additional costs with their potential supervisor prior to application. Once students are in the Department, there are limited Department funds that students can apply for. However, this is likely to be insufficient to cover all costs, so students may have to find additional funding elsewhere.

Overseas applicants will need to be aware that different conditions apply depending on the topic of the research project. Applicants should select the "PhD (probationary) in Geography" (EAGG22) when making an application and the correct course code will be chosen by the Department at the offer stage, whether EAGG21 (Social Science and Humanities) or EAGG22 (Natural Science). The course code will affect the level of fee you pay if you are an overseas applicant and whether or not you need an ATAS statement: EAGG22 requires an ATAS statement for your visa application and carries a Science fee.

38: MPhil in Heritage Studies

Fieldtrips specified as part of the course do not incur additional costs to students.

A non-compulsory fieldtrip to Wessex, available to all MPhil students in the Department, is charged at a heavily subsidized rate, typically £50.00.

Costs may be incurred by students in the course of data collection or fieldwork for their dissertation depending on their topic. Such topics or methods are not prescribed and alternative projects incurring no additional costs will be available to all students.

39: PhD in History

Many of our students choose to spend a period working away from Cambridge, to conduct research relevant to their PhD. The Faculty has some funds available to help cover the associated fieldwork costs, but demand for these funds is always very high. Students are advised to consider their fieldwork requirements when submitting an application, and to discuss these during the interview where possible.

40: PhD in History of Art

Most of our students find it useful to work with a laptop.

While our libraries are excellent, some students prefer to purchase books for their own use. They may also choose to undertake research which necessitates specialist equipment and materials.

The Department advocates that students plan for research for which they can arrange funding for fieldwork, visits and research as these can take place overseas and be costly.

41: MPhil in History of Art and Architecture

Most of our students find it useful to work with a laptop.

Whilst our libraries are excellent, some students prefer to purchase books for their own use. They also may choose to undertake research which necessitates specialist equipment and materials.

The Department advocates that students plan for research for which they can arrange funding for. Fieldwork, visits and research which take place overseas can be costly.

42: MPhil in Industrial Systems, Manufacture, and Management

Additional Costs: £ 4,500

43: EPSRC CDT MRes + PhD in Integrated Photonic and Electronic Systems

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

44: MPhil in International Relations and Politics

There is no funding available from the Department for MPhils undertaking fieldwork. Students wishing to undertake research abroad will incur costs for flights, accommodation and subsistence. If you have any concerns about this please speak with the admissions administrator before applying, noting that research abroad is not a mandatory part of the MPhil course.

45: PhD in Land Economy

Fieldwork costs: some projects will involve fieldwork away from Cambridge, costs of travel, accommodation and any local costs for accessing sites, documentation or data should be considered. Some financial assistance is available from the Department for fieldwork costs; students may also be able to obtain some funds from their College, but students should be aware that they may need to cover some of the cost of their fieldwork themselves.

46: MPhil in Latin American Studies

Students wishing to undertake research or fieldwork in Latin America will incur costs for flights, accommodation and subsistence. There are sources of funding available to students to apply to for research trips, eg the Simon Bolivar Fund and the Santander Student Travel Grants scheme, but students should not expect all of the costs of their research trip to be covered. If you have any concerns about this please speak to a member of CLAS staff before applying noting that research abroad is not a mandatory part of the MPhil course.

47: PhD in Latin American Studies

Students wishing to undertake research or fieldwork in Latin America will incur costs for flights, accommodation and subsistence. There are sources of funding available to students to apply to for research trips, eg the Simon Bolivar Fund and the Santander Student Travel Grants scheme, but students should not expect all of the costs of their research trip to be covered. If you have any concerns about this please speak to a member of CLAS staff before applying noting that research abroad is not a mandatory part of the course.

48: MRes + PhD in Management Studies

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

49: Master of Music

Students undertaking the *Vocal Performance* pathway or those choosing a recital option will be required to take compulsory practical music lessons. The Faculty funds such lessons up to an agreed amount – if the music teacher chosen by the student charges more than this, then the difference between the agreed amount and the actual amount must be paid by the student.

50: MAST in Materials Science

All MAST courses are treated as undergraduate courses for fee purposes. Overseas students are therefore also charged the undergraduate College fee. This varies from College to College and is in addition to the University Composition Fee and maintenance costs. See the [International Fees and Costs page](#) on the University Undergraduate Study website for more details.

51: MRes + PhD in Mathematical Genomics and Medicine

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

52: MAST in Mathematical Statistics

All MAST courses are treated as undergraduate courses for fee purposes. Overseas students are therefore also charged the undergraduate College fee. This varies from College to College. The *estimated* financial liability for the overseas College fee for admission in 2017–18 ranges between £6,580 and £12,264 and is in addition to the University Composition Fee and maintenance costs.

53: MD (Doctor of Medicine)

The fee for the entire course can be paid in five equal installments. Any outstanding balance is payable before submission of the dissertation.

54: Wellcome Trust MRes + PhD in Medical Science (Infection, Immunity and Inflammation)

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

55: MPhil in Medieval History

Students on the MPhil in Medieval History are required to attend a pre-sessional intensive Latin course and there may be costs associated with this additional study, including accommodation and living expenses.

56: Wellcome Trust MRes + PhD in Metabolic and Cardiovascular Disease

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

57: MPhil in Micro and Nanotechnology Enterprise

Students should be aware that they will need to be available in Cambridge for up to two weeks after the hand-in date for their project dissertation (usually mid July) for a viva voce examination. This will mean that additional living costs may be incurred.

58: MPhil in Multi-disciplinary Gender Studies

Additional Costs: £ 40

Students purchase MPhil core reading text packs for 24 subjects, at a total cost of £40 per student.

59: PhD in Multi-disciplinary Gender Studies

Students wishing to undertake fieldwork will incur costs for flights, accommodation and subsistence. There are only limited sources of funding available from Colleges and other University sources to support fieldwork, and this should be factored into your decision to apply. If you have any concerns about this please speak to the Centre Administrator before applying, noting that research abroad is not a mandatory part of the course.

60: MPhil in Music

Students opting to carry out fieldwork are advised to make additional financial provision of up to £1,000. Students intending to take the recital option will need to make additional financial provision for lessons at an approximate additional cost of £1,200.

61: PhD in Music

Applicants opting to carry out fieldwork are advised to make additional financial provision of up to £1,000.

Applicants who are considering practice-based research in musical performance and whose research programme would necessitate instrumental or vocal tuition alongside their academic supervision are advised to make additional financial provision. Applicants should discuss any additional costs with their potential supervisor prior to application.

62: EPSRC CDT MRes + PhD in Nanoscience and Nanotechnology

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

Certain projects may require additional funds for laboratory, fieldwork and long-term attachment costs. This could include equipment, books, IT, photocopying, bespoke training, travel for conferences, research trips, summer schools and fieldwork costs.

Supervisors are often able to cover these costs, or partially contribute to these costs, depending on the financial resources available. Where not possible, or where research related costs are not specifically included in a stipend, or if students are self-funded, students will usually be expected to raise the associated research costs themselves. In some cases research costs may be much higher, for example if a long-term attachment is required, and in these cases applicants should agree with their supervisor what an appropriate amount might be, or consider a more feasible project, before accepting an offer or signing the Financial Undertaking Form.

63: MAST in Physics

All MAST courses are treated as undergraduate courses for fee purposes. International/overseas students are therefore also charged the undergraduate College fee, which is in addition to the University Fee and maintenance costs.

International/overseas applicants: Additional College fees to calculate the combined fee

Each of the Colleges is a separate institution, and you are required to be a member of both a College and the University to study. College fees differ because they are set independently by each College. You are strongly advised to view the Colleges' pages in the undergraduate prospectus and College websites to gain a full understanding of the character of each of the Colleges as you make a decision about your application.

64: MPhil in Physics

Certain projects may require additional funds for laboratory, fieldwork and long-term attachment costs. This could include equipment, books, IT, photocopying, bespoke training, travel for conferences, research trips, summer schools and fieldwork costs.

Supervisors are often able to cover these costs, or partially contribute to these costs, depending on the financial resources available. Where not possible, or where research-related costs are not specifically included in a stipend, or if students are self-funded, students will usually be expected to raise the associated research costs themselves. In some cases research costs may be much higher, for example if a long-term attachment is required, and in these cases applicants should agree with their supervisor what an appropriate amount might be, or consider a more feasible project, before accepting an offer or signing the Financial Undertaking Form.

65: PhD in Physics

Additional costs may be incurred in relation to PhD associated fieldwork and/or research trips/long-term attachments, bespoke to the individual student and project. These could also include equipment, books, IT, photocopying, bespoke training, travel for conferences and summer schools.

Supervisors are often able to cover or contribute towards these costs, depending on the financial resources available. Where not possible, or where research-related costs are not specifically included in a stipend, or if students are self-funded, students will usually be expected to find additional funding elsewhere, e.g. University/College. In some cases research costs may be much higher, for example if a long-term attachment is required, and in these cases applicants should agree with their supervisor what an appropriate amount might be, or consider a more feasible project, before accepting an offer or signing the Financial Undertaking Form.

66: MPhil in Polar Studies (Scott Polar Research Institute)

Although not mandatory, very occasionally a student may conduct a short period of fieldwork. These trips may incur additional travel costs for the student, but there are opportunities to apply for funding through colleges and other sources.

67: PhD in Polar Studies (Scott Polar Research Institute)

Additional costs may be incurred in relation to PhD associated fieldwork and/or research trips. These will be bespoke to the individual student and project and applicants should discuss any potential additional costs with their intended supervisor prior to application. Once students are in the Department, there are limited Department funds for which students can apply to cover such additional costs. However, this is likely to be insufficient to cover all costs, so students may have to find additional funding elsewhere, e.g. University/College funding.

The Department of Geography will decide into which category – EASP22 Polar Studies (Natural Science) or EASP21 Polar Studies (Social Sciences and Humanities) – your application falls depending on the topic of your research project. This will affect the level of fee you pay if you are an overseas applicant and also whether or not you need an ATAS statement. EASP22 Polar Studies (Natural Science) carries the Science fee and requires an ATAS statement, while EASP21 Polar Studies (Social Science and Humanities) carries the Arts fee and does not require an ATAS statement.

68: PhD in Politics and International Studies

Students wishing to undertake fieldwork will incur costs for flights, accommodation and subsistence. There are only limited sources of funding available to students to apply to for research trips. If you have any concerns about this please contact the administrator before applying, noting that research abroad is not a mandatory part of the course.

69: PhD in Psychology

If any fieldwork is required, students can apply for limited funding from the Graduate Education Committee. However, this is likely to be insufficient to cover all costs, so students may have to find additional funding elsewhere.

70: MPhil in Public Policy

Students on the course undertake a compulsory work placement and applicants should be aware that neither the University nor the Department cover day-to-day subsistence costs incurred during the placement. Depending upon the location of the placement these costs may be higher than the subsistence costs which would be incurred while living in Cambridge for an equivalent time period (placements are typically four to six weeks). Applicants need to assess and allow for any additional expenses related to their placement.

71: MAST in Pure Mathematics

All MAST courses are treated as undergraduate courses for fee purposes. Overseas students are therefore also charged the undergraduate College fee. This varies from College to College. The *estimated* financial liability for the overseas College fee for admission in 2017–18 ranges between £6,580 and £12,264 and is in addition to the University Composition Fee and maintenance costs.

72: MPhil in Scientific Computing

Certain projects may require additional funds for equipment, books, IT, photocopying, bespoke training, or travel for conferences, trips and fieldwork costs. Applicants should confirm with their supervisor what an appropriate amount might be before accepting an offer or signing the Financial Undertaking Form.

73: EPSRC CDT MRes + PhD in Sensor Technologies and Applications

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

74: MPhil in Social Anthropology

Students opting to undertake fieldwork as part of their dissertation research may incur additional costs for travel and equipment. Such students are advised to make additional financial provision for this.

75: MRes in Social Anthropology

Students opting to undertake a fieldwork-based thesis may incur additional costs for travel and equipment. Such students are advised to make appropriate financial provision for this prior to commencing the course.

Students progressing from the MRes to the PhD will normally undertake 12-18 months' ethnographic fieldwork during which they may incur additional costs for travel, maintenance and equipment. Students are able to apply to the University Fieldwork Fund for assistance in meeting these costs and will receive guidance about other funding sources for fieldwork. Visit the [Funding Postgraduate Fieldwork Page](#) on the Department of Social Anthropology website for details.

76: PhD in Social Anthropology

All students must normally undertake 12–18 months' ethnographic fieldwork during which they may incur additional costs for travel, maintenance and equipment. Students are able to apply to the University's fieldwork fund for assistance in meeting these additional costs and will receive guidance about other funding sources for fieldwork. 77: Wellcome Trust MRes + PhD in Stem Cell Biology

Please note that fees shown for the PhD portion of the course are an estimate based on the current PhD fee. Fees applicable to your year of entry to the PhD have not yet been confirmed, but are likely to be 5% higher than the estimate presented.

78: MPhil in Technology Policy

Additional Costs: £ 1,000

In addition to the University Composition Fee and College fees, an additional fee of £1,000 is required. Please note that this fee must be paid by 31 October 2019. The additional cost is for supplementary activities and includes funds for:

- £400 towards the cost of the orientation week and stakeholder engagement events throughout the year. These events will include an induction visit to London for policy discussions with leading public and private sector organisations and visitor seminars. This amount will cover the organisation of visits, travel, meal allowances and any other miscellaneous costs associated with the setup. This fee is non-refundable.
- £600 towards the cost of an educational trip programme to Brussels or another European city. This amount will cover the organisation of the trip, travel, accommodation, allowance for meals, company visits and costs for events organised as part of the programme. In the event that a student cannot make the trip, the non-recoverable costs will not be refunded.

79: MPhil in Veterinary Science

Not normally applied. If, exceptionally, a student proposes a very costly project not funded through the Department's research income and a supervisor can be found for this project, an appropriate level of additional fee may be required.

80: PhD in Zoology

You are likely to also need funding towards your research costs, which will depend on the exact nature of your project.
